**Narrative/Case Notes (1)**

On 02/13/2019 at 09:54 hours, Deputy Porter (3294) responded to a Murder/Non-Negligent Manslaughter at 150 Clinic Pvt Dr. Upon arrival officer Bragg and myself and several Kingsport Police Officers entered the business and came in contact with victim Kelly Weaver lying on the floor with an apparent gunshot wound. Suspect Harry Weaver was lying in the floor with several apparent gunshot wounds. Witness Larry Seagroves was standing over suspect Harry Weaver pointing a semi automatic hand gun on him. Witness Larry Seagroves was ordered to put his gun down and he immediately complied. Witnesses stated suspect Harry Weaver came in the back of the dentist office and shot victim Kelly Weaver . Witnesses further stated victim Kelly Weaver was going through a divorce with suspect Harry Weaver . suspect Harry Weaver vehicle was located at the next business over in the parking lot. CID arrived on scene and took over the scene.
